This charge includes transfer of remains from a local airport, temporary shelter of remains, transportation of remains to a local cemetery, and the staff services required. It does not include the services of the staff or use of the facilities for any visitation and/or services or rites prior to the final disposition of the body.

(The US Postal Service is the only carrier that will accept cremated remains for mailing. Other shipping services such as FedEx or UPS prohibits the transport of cremated remains.)
